RE: Staff Report - Purchase of Staff Vehicles

BACKGROUND:

During the January 11, 2023, Regular Board of Directors meeting, the Board unanimously authorized a midyear budget appropriation of \$98,091.48 for the purchase of a command vehicle and associated equipment to replace a 2005 Ford Expedition with over 173,000 miles. On May 25, 2023, the District took possession of the 2023 Chevrolet Tahoe, and appropriated \$48,091.42 in FY22-23 for the purchase. The command vehicle is now ready to be upfitted with necessary equipment for emergency response.

RECITALS:

This Tahoe will serve as the new Battalion Chief command vehicle requiring purchase and installation of radios, lights, sirens, and various command equipment. District staff recently obtained updated quotes for the equipment and installation upfit totaling \$40,131.54. This cost is broken down as follows:

Funds for the vehicle upfit were included in the recently adopted FY2023-24 Preliminary Budget.

RECOMMENDATION:

Staff' recommends the purchase of equipment and installation needed to upfit the new command vehicle be approved by the Board. The funds will be taken from Hercules Developer Fees.

ACTION:

Staff requests the Board of Directors authorize the purchase of equipment and installation for the new command vehicle in the amount of \$40,131.54.



Labor Relations / Personnel

All shifts are fully staffed, no work related injuries. Reported, no one on long term leave. Working with labor on career development options/opportunities for Acting Battalion Chiefs.

Operations

Incident Activity- Quint 76 Crews responded to a rescue of a person on a roof with a medical emergency. The aerial ladder was deployed and rescue was safely affected. Crews responded to several grass fires. On July 2 there was a .5-acre fire near Bio Rad-11 units, no injuries, no structural damage. We had an extra Type III Brush unit staffed as part of a county wide Task Force. Units throughout the county were stretched with a multitude of calls, including a significant fire in our southern Walnut Creek area, and three working structure fires throughout the night. All this in addition to over 50 fires between 2000-0000 hours, an incident with multiple gunshot victims, and finally, the unfortunate annual incident of a person blowing their hand off due to fireworks, which RHFD responded to.

Training

Training- An active shooter drill, with HPD, took place over a 2-day period. 15 of our 18 rank and file members were able to attend. All West County Fire Agencies attended including RHFD, Con, ECFD, RMD, Crockett and AMR. Annual Fit test of SCBA mask completed. Bayo Vista/Refinery wildland training burn was conducted.
